The project includes adding enclosed parking, loading lanes, storage warehouse, a fully operational fleet building among many other specialized operations facilities.</i></p> <p><i>Materials used on the job include pre-engineered metal building structures, insulated precast wall panels, structural steel, insulated metal panels and both EPDM roofing and standing seam roofing.</i></p> <p><i>This Bid Package includes all remaining scopes of work that have not been previously bid out. BID DUE DATE	Bids will be received for Bid Package #3 until 2:00pm on Tuesday August 29th, 2017 by Hausmann Construction at 8545 Executive Woods Dr., Suite #1, Lincoln, NE 68512. Bids may also be emailed to estimating@hausmannconstruction.com or adam@projectcontrol.com . Please direct all Bids to the attention of Adam Hoebelheinrich.

LENGTH OF VALIDITY OF BID All Bids shall be valid for acceptance by the Contractor for a period of **Forty-Five (45) calendar days** after submission of the Bid(s).

INTERPRETATION AND ADDENDA Requests for interpretations, clarifications, corrections or changes of the Bidding Documents must be made in writing at least **seven (7) calendar days** prior to the date for receipt of Bids. No Addenda will be issued later **than two (2) business days** prior to the date for receipt of Bids except for the limited situations set forth in the Instructions to Bidders.

SUBSTITUTIONS Substitutions will be allowed as provided in the Instructions to Bidders and pursuant to Division 01.

INSURANCE REQUIREMENTS Subcontractors will not be allowed on site until they have fully complied with the insurance requirements.

PREVAILING WAGES [Prevailing wages are not required on this Project.]

MBE/WBE GOALS [MBE/WBE goals are not required on this Project. However, it is requested that Bidders actively solicit minority contractors, suppliers and their organizations.]

TAXES/EXEMPTIONS Project is not tax exempt. Bidders shall include all applicable taxes within their bids. However, the Owner is currently seeking tax exemption status with the expectation that it will be granted at/near project completion. That said, material tax should be broken out and tracked as the Owner will be seeking a tax credit retroactively at/near project completion.

BID BOND Bid Bond of 5% is Required.
